



PURCHASE AGREEMENT

This Purchase Agreement, dated _____ (hereinafter “Agreement”), is by and between AK Labradors (hereinafter “AKL”) and _____ (hereinafter “Owner”) and sets out the terms and conditions of the sale of _____ (hereinafter “the Dog”) and the Owner’s obligations with respect to the care and welfare of the Dog after AKL transfers the Dog to the Owner.

1. Payment for Sale of Dog:

The Owner shall pay AKL a non-refundable sum of \$_____ for the Dog – due upon the time of pick-up/delivery. The description of the Dog and its care pre-transfer to the Owner are as follows:

2. Representations by AKL:

AKL has taken reasonable care in the breeding and post-birth treatment of the Dog and represents and warrants that the Dog is in good health and has received appropriate care, including medical care. The AKL shall not replace this Dog or refund monies for the sale of the Dog for any reason, with the sole exception of the Dog dying of an unforeseen medical condition within 60 days of the Owner taking possession of the Dog.

3. Commitments by the Owner:

Owner agrees to provide a caring and loving home to the Dog, along with appropriate veterinary care, housing, training and social stimulation. The Owner shall promptly obtain a license for the Dog and will keep all immunizations up to date.

If the Owner is unable to care for the Dog, the Owner will find a good home for the Dog and shall provide written notification to AKL of the transfer/sale of the dog to a new Owner. If the Owner cannot find a comparable situation for the Dog, the Owner shall return the Dog to AKL. The Owner agrees that it will never surrender the Dog to a pound or rescue organization.

The Owner agrees that the welfare of the Dog is the Owner's sole responsibility. However, the Owner agrees to provide notification to AKL if the Dog becomes lost or stolen.

The Owner agrees to spay or neuter the Dog by 24 months of Age.

4. Limited AKC registration:

Owner understands and agrees that the dog has limited AKC registration and is not eligible to compete in AKC Conformation classes or events. Owner shall pay an additional \$50 for AKC papers. This price is non-negotiable, and registration is required per Agreement. This Dog is not eligible to have its offspring registered with the AKC, however, this Dog may compete in AKC performance Events.

5. Release by Owner:

After taking possession of the Dog, the Owner hereby releases AKL from any and all claims, including for personal injury, related to or associated in any way with the Dog.
